Summary of Significant Results	THE MEETING IS VALID  A general over view has been made for all the WPs with reference to the Work Plan agreed and to the reporting period object of this Meeting:  WP1 no critical situations to be to be submitted and examined by the Executive Board. All 3 Deliverables planned (D1.1, 1.2 and 1.3) in the reporting period issued and uploaded on EU portal. Deliverables approved by EU without comments.  WP2 CHC/ESTECO Scenario analysis is moving forward. Some important aspects need to be more deeply investigated (North Europe, Black Sea) Communications and exchange of information, mainly with VTG for the Black Sea scenario, need to be strengthened – See Actions Items  WP3 CNGV has completed the laboratory experimental tests, in presence of ABS, on the stainless steel base material specimens for liners. Laboratory tests on carbon fiber samples supplied by DOWA will start shortly. NAVALPROGETTI is completing the design of hydroforming mold and has supplied BMP with the first MTO for the procurement of raw material.  WP4 BMP is finalizing the PO to Gortani for the construction of the 16 stainless steel liners: deadline for PO 15 October 2017. First liner due date on Jan 2018. Overall studies for the prototyping pilot line arrangement in progress. NAVALPROGETTI/CNGV ask to be present at the various technical meetings to be arranged by BMP, in

assistance for defining welding and machining process necessary for the construction of the hydroforming mold. – See Action Items.

**WP5** NAVALPROGETTI confirm startup of CNG Ship basic design during the present month of October 2017 as per Work Plan. RFQ for experimental towing tank tests ready to be forwarded to the tenderers.

**WP6** Preliminary unloading situation in Ukraine submitted by VTG. Works in progress for the various other scenarios individuated in WP2 **WP7** SINTEF activities planned to start on Feb 2018

**WP8** ABS activities planned to start in full on beginning 2019. ABS is anyhow attending to the specimen technological tests on the base materials performed at CNGV care, as necessary for the certification of prototypes

**WP9** All foreseen dissemination actions performed by PNO as planned in the reporting period. GASVESSEL website is ready and working. PNO to verify with Partners which deliverables they want to be uploaded on the website and consequently made "public" in addition to the uploading on EU portal. NAVALPROGETTI informs PNO about its willing to attend to TRA2018 conference in Vienna and to NAV 2018 in Trieste (as the whole GASVESSEL Consortium).

**WP10** All 3 Deliverables on Ethics (D10.1, 10.2 and 10.3) submitted to Partners for quality check and uploaded on EU portal. Waiting for EU approval.
