Summary of Significant Results	During the turn of table greetings, Ms. Ute Spring informed the Executive Board that she will move to DOW and leave DOWAKSA. Ms. Sadikoglu has been carrying out financial, commercial and managerial roles within Dowaksa. Coordinator took then the word in the person of Mr. Spartaco Angelini. He informed the EB about the following points. General Status of the Project The project is progressing as expected. No criticalities pointed out in the Quarterly Status Reports received from Partners. Coordinator did not receive the Quarterly Reports from Partners ABS, HLL, CNGV, VTG but the technical and financial reports received on month 18 (November 2018) have been considered valid for this purpose as well. On the 5 th of February, during the Review meeting with the P.O. Renata Kadric, no issues were arisen from the technical point of view. Some recommendations were provided but not officialized yet for Deliverable 2.1 produced by CHC.
