Summary of Significant Results	 Meeting started at 09.37 1) The Coordinator Loris Cok opened the meeting by welcome speech to the attendees. 2) It has been confirmed that the next Consortium meeting will be held on week 42, between 16th and 18th of October. A doodle will be sent in order to set the date. 3) Status of each WP guided by Mr. Spartaco Angelini: a) Spartaco Angelini informed about the progress of WP1: he reported that there will be a need of amendment of the GA due to the introduction of new Linked Third Parties (ABS Italy) for Partner ABS Hellenic in order to report the costs of the surveyors coming from other ABS entities. Moreover, it has been pointed out that in October and November 6 deliverables are due by Partners BMP (3 Del.), VTG (2 Del.), Sintef (1 Del.). Lastly, it has been stressed the need to deliver the Deliverables well in advance according to the agreed Quality Procedure in force for Coordinator's and Partners quality check. This would avoid the recent problems occurred with last minute deliveries to Coordinator. b) WP3: Giovanni Fratti informed that the on-going activities are in line with the programs. Recently an electric board problem occurred but it has been solved with no impact on the schedule. 		





<i>c)</i>	WP4: Paolo Maschio informed that they are performing the tuning of the components and that the liners no. 4-5-6 have been ordered and will be hydroformed in Sep/Oct. He informed that the location (a quarry) for the burst tests has been chosen (CNGV is finalizing a formal agreement with the quarry management). Safety procedures to be applied inside the experimental pilot line and in the burst test location are under finalization.
d)	WP5: Loris Cok reported that the basic design is finished (12milion NM3 delivery capacity), the tank tests with the air cushion application are completed. It resulted that the vessel has a reduction on the resistance of 13% thanks to this air cushion device (meaning a reduction of emissions). Functional design is ongoing. The basic design of the second type of vessel (9milion NM3 delivery capacity) has started.
